All copy and/or agency produced materials must be received at least 48 hours prior to broadcast.

Billing will occur at end of underwriting schedule or on the first day of each standard broadcast month. Bills are payable upon presentation and are delinquent 30 days after billing. A finance charge of 1½% per month (annual rate of 18%) will be charged on delinquent account. \$50 minimum.
